PUBLIC NOTICES REGARDING FIRE DISTRICT ELECTION

The Cahaba Valley Fire and Emergency Medical Rescue District Election shall be held on August 31, 2021 between the hours of 7:00 a.m. and 7:00 p.m. at North Shelby Baptist Church, 4100 Belcher Dr., Birmingham, AL 35242.

Pursuant to §21-4-23(b), of the *Code of Alabama* (1975), notice is hereby given of the following with regard to Shelby County, Alabama:

1. Instructions, printed in large type, conspicuously displayed at each voter registration site and polling place, sufficient to provide hearing impaired and seriously visually impaired individuals with adequate information as to how and where they may register and vote shall be available at each voter registration site and polling place.
2. The polling place shall have an AutoMARK Voter Assist Terminal for use by individuals with disabilities who would otherwise be prevented from voting because of their inability to mark a paper ballot.
3. Every individual, including individuals with a disability or elderly individuals, may select a person of his or her choice to accompany such individual into the polling place to assist with the marking and casting of a ballot, provided the person providing assistance is not the voting individual's employer, agent of the voting individual's employer, or an officer or agent of the voting individual's labor union.

There will be a public test of the precinct counter election equipment to be used in said election on August 26, 2021 at 8:30 a.m. at the Shelby County Election Warehouse, Columbiana, Alabama.

Pursuant to §17-8-9A of the *Code of Alabama* (1975), notice is hereby given that there will be a school of instruction for poll workers which shall be held at 1:30 p.m. on August 26, 2021 at North Shelby Baptist Church. 
